Bhagwan Buddha Homoeopathic Medical College and Hospital, Bengaluru, Karnataka is functional since 1998 and has applied for permission for sanction of BHMS course with intake capacity of 100 seats for the academic year 2024-25. The College Part 1 information has been received for information on compliance to MSR 2013. The Medical Assessment and Rating Board has examined the profile of the College as to whether the college fulfils the Minimum Standards Requirements to be fulfilled as per the prevailing regulations under clause 28 of NCH Act 2020.

On careful examination of the report, the Medical Assessment and Rating Board has observed following shortfall.

#### 1. Hospital details

• IPD and OPD case records should be maintained with demographic details of the patient such as Name, Age, Sex, Address, Phone number. All follow up attendance should be recorded on the case records. Case sheets shall be maintained with complete case history, analysis and evaluation and repertorisation and made available in Medical Record Room for academic purpose of students and follow up of patients.

#### 2. Miscellaneous

• Form 16 of all the staff is not from traces portal.

Considering the aboveobservations and facilities available, MARBH has decided to issue Conditional Permission to Bhagwan Buddha Homoeopathic Medical College and Hospital, No.103/6, 40 Feet BDA Road, NGEF Layout, Mallathalli, Bengaluru, Karnataka- 560056 for continuing BHMS course with intake capacity of 100 seats for the academic year 2024-2025.

All deficiencies noticed shall be rectified within a period of one month and the compliance report shall be submitted for verification.

It is further to mention that all admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of 100 UG seats shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/UT govt as designated by

Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to college can be withdrawn or denied in the subsequent year if college is found deficient in compliance to MSR 2013 anytime during the academic year.
