Sub: Application for permission matter of functioning of Bhagwan Buddha Homoeopathic Medical College and Hospital, No. 103/6, 80 Feet BDA Road, V NGEF Layout, Mallathalli, Bangalore, Karnataka-560056 with 100 seats in UG (BHMS) course for the academic session 2025-26 reg.

Sir,

Bhagwan Buddha Homoeopathic Medical College and Hospital, No. 103/6, 80 Feet BDA Road, V NGEF Layout, Mallathalli, Bangalore, Karnataka-560056 has submitted an application for the permission for sanction of UG BHMS Course with 100 seats during the academic year 2025-26. The College has submitted the Part I information in which the entire functional profile has been narrated. MARBH conducted Inspection on 1/05/2025 & 2/05/2025. The Medical Assessment and Rating Board has examined the College as to whether the college fulfils the Minimum Essential Standards as per the prevailing regulations under clauses 26 and 28 of the NCH Act 2020. On careful examination of the report, the Medical Assessment and Rating Board observed the following shortfalls: -

1. Hospital functioning: -

- a) The central hospital registration is maintained manually.
- b) Ambulance, Lifts and Ramp in hospital are not available.
- c) The average number of patients in OPD per day (300 days) is 278 /day against the requirement of 300/day.

2. Miscellaneous

- a) NABH accreditation or registration on portal for hospital not done.
- b) The salary of teaching staff and non-teaching staff is not as per MES 2024.
- c) Statistical Assistant is not available in the Department of Community Medicine, Research Methodology & Biostatistics.

3. Considering the above observations during inspection, MARBH has decided to issue Conditional Permission to Bhagwan Buddha Homoeopathic Medical College and Hospital, No. 103/6, 80 Feet BDA Road, V NGEF Layout, Mallathalli, Bangalore, Karnataka-560056 for UG BHMS Course with 100 seats for the academic year 2025-26 on the basis of following condition: -

- a) The salary of the staff should be as per the criteria mentioned in MES 2024.
- b) NABH accreditation or registration on portal for hospital to be done immediately.

- c) The hospital information system should be available and central hospital registration should be maintained computerized.
- d) Ambulance, Lifts and Ramp in hospital shall be made available.


4. All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of 100 UG seats shall be treated as All India Quota. Counseling for seats under all India quotas shall be conducted by respective Counseling Authority of State/UT govt as designated by Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT.

5. The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

6. **Conditions under point 3 should be fulfilled within a period of one month and the compliance report shall be submitted for verification to the office, failing which permission for the academic year 2025-26 may be withdrawn.**
